a. Human Resources

Trustee Newman-Bale deferred to the Associate Superintendent of Labor Relations and Legal Services, Coni Taylor, to provide an update on the following items:

i. Staffing update

Ms. Taylor shared that the district is continuing to hire in shortage areas and hold Open Interviews. The district is continuing to offer incentives for early notification for retirement. The largest incentive ends on Friday, December 20, 2024. At this time, the district has received 15 confirmed retirements from the Traverse City Education Association (TCEA) and anticipates five (5) more to be completed by December 20. These numbers are helpful as we look at what areas need to be filled from a hiring and budgeting perspective. The number of Special Education staff leaving is concerning, and the district will continue to recruit in that area.

ii. Tenure

Ms. Taylor shared that Thomas Sheppard is being recommended for tenure, which will be brought to the December 9, 2024 Board meeting under the Superintendent's Report.

b. Communications Update

Trustee Newman-Bale deferred to the Executive Director of Marketing and Communications, Ginger Smith, to provide an update on the following items:

i. Light Parade

Ms. Smith shared that Courtade Elementary students, families, and staff participated in the downtown Traverse City annual Light Parade. She shared that the Student Support Network received donations as a result of the QR codes that were handed out during the parade.

ii. Student Support Network (SSN) Holiday Update

Ms. Smith reported that SSN is gearing up for the holidays to ensure that needs are being met over the duration of time that students are not in school. She shared that her department is also working with local agencies to ensure holiday meals and gifts are provided in alignment with holiday giving that is being done at the building level.
