TCAPS is once again partnering with Secure Environment Consultants (SEC), formerly known as Secure Education Consultants, to enhance safety measures for after-school activities. This partnership will focus on assessing various events held on school property, including sports competitions, music and artistic performances, and larger gatherings involving the community. The goal is to identify and implement strategies that ensure a secure environment for students, staff, and attendees. By leveraging SEC's expertise, TCAPS aims to strengthen its approach to event safety and preparedness. The assessment process will span most of the 2025 calendar year, and address potential risks while offering tailored recommendations for improvement. This continued partnership underscores TCAPS's commitment to providing a safe and welcoming environment for learning and community engagement, both during and after school hours.

b. Grant Acceptance: The Grand Traverse Band of Ottawa and Chippewa Indians 2% Grant
