## b. School Safety Update

As considered during the consent portion of this meeting regarding bids and purchases, TCAPS is upgrading its two-way radio communication system. This will replace portable radios for key crisis team leaders, building administrators, and schools district-wide. The current radio system uses an older analog very high frequency (VHF) range that restricts coverage areas in and around each school, making it difficult to hear and transmit messages in a clear and timely manner, with a limited coverage area.

## c. Adoption of Bond Authorizing Resolution

The Board considered adoption of a Bond Authorizing Resolution authorizing actions necessary to facilitate the bond sale and the delivery of bonds. Ms. Thomas-Hill explained that the district plans to sell the bonds in February, with the sale closing in March. This bond sale will include \$10 million from the 2018 bond, fully exhausting that authorization, and an additional \$80 million from the first 2024 bond authorization. These bonds will be sold in a 10-year series through a competitive bidding process, similar to previous bond sales. Ms. Thomas-Hill also mentioned that the recent property value increases have exceeded the initial projections made by the financial advisor. The district will continue to monitor the situation closely to ensure that a new bond authorization is sought before the current authorization falls below 3.1 mils.

#### d. Electric School Bus

The Board considered the purchase of an electric school bus. The district has received \$200,000 from the EPA Clean School Bus Rebate and \$280,000 from the Section 74(b) Clean Bus Energy Grant to purchase and pilot an electric bus. The district will amend the grant to include coverage of installation.

Approval to purchase one (1) EV Conventional 77-Passenger electric bus in the amount not to exceed \$449,312, funded by the Section 74(b) Clean Bus Energy Grant and the EPA Clean School Bus Rebate.

## e. Bond Update - Central High School

Dr. VanWagoner recommended the Board approve TMP Architecture to undertake bond-related projects at Central High School. These projects include constructing a secure main office vestibule, renovating the gym and wrestling room, and developing a design for a multi-purpose turf gym. Additionally, Dr. VanWagoner asked the Board for authorization to collaborate with the Board President to establish a fundraising committee. This committee would focus on raising funds for multi-purpose facilities at both West Senior High School and Central High School.

Approval of a contract with TMP Architecture for the design of the Central High School renovations including the main office safe and secure entryways, gyms, including a potential rendering for a turf gym, and the wrestling room.

In the meantime, he will be looking for some leased or available business space for central office staff during the time that students are in Glenn Loomis for renovation at Central Grade School.
