6. STUDY SESSION - Budget Formulation

Dr. VanWagoner introduced Assistant Superintendent Christine Thomas-Hill, who provided the Board with an overview of the annual budget development process, including preparing budget amendments, the Mission Based Budget (MBB) process, and how the budget aligns with the district's strategic plan. Ms. Thomas-Hill also presented historical data on student enrollment as well as the impact of operating millage on the foundation allowance. She explained how various expenditures, including salaries, benefits, purchased services, and supplies, are budgeted each year, along with historical information on the district's fund balance. Dr. VanWagoner noted that the budget process will begin before the next round of strategic planning, so any feedback from the Board regarding the budget should be submitted by January 2025.
